

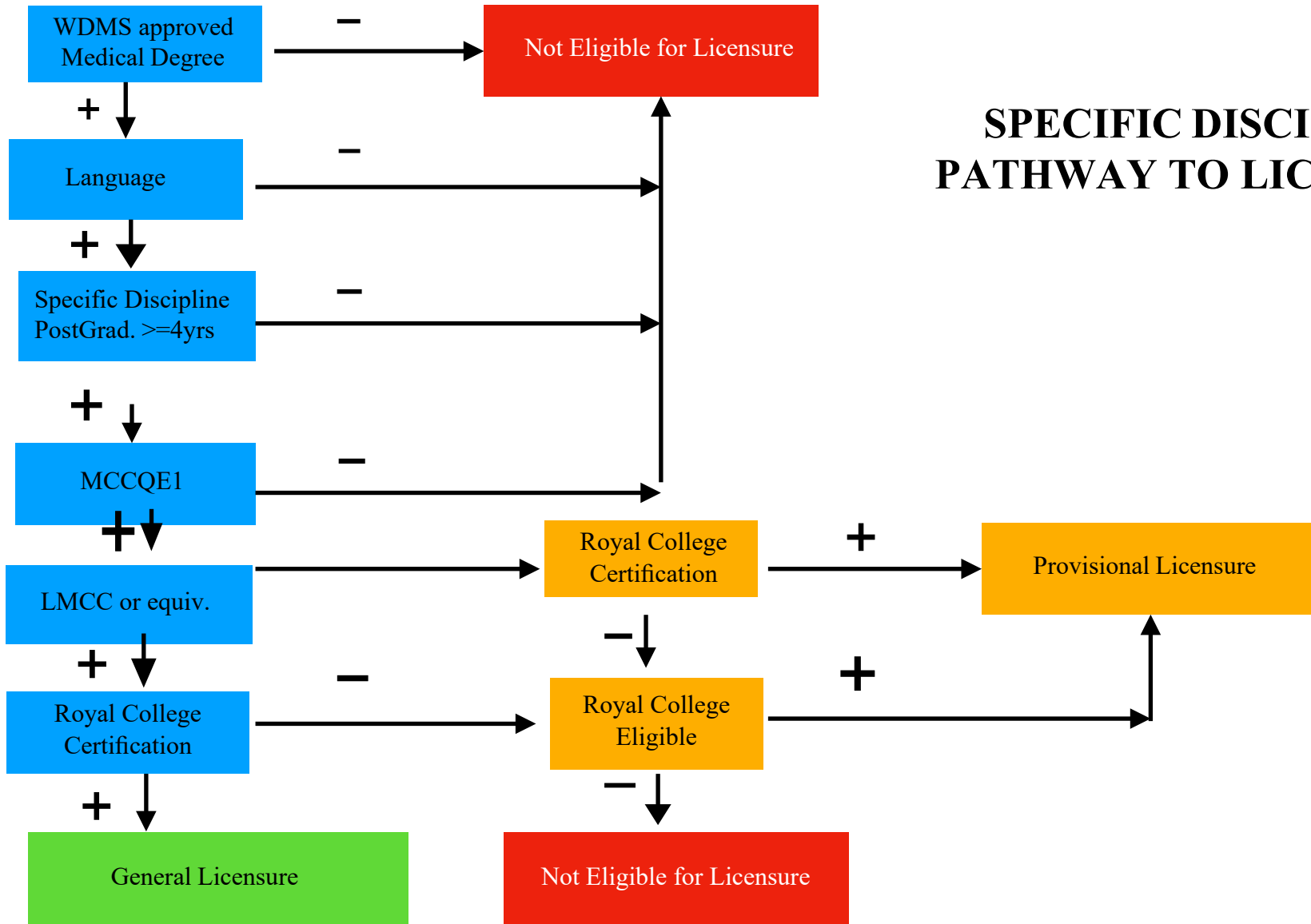

SPECIFIC DISCIPLINE PATHWAY TO LICENSURE





Specific Discipline Licensure Application Requirements

Consistency of Practice: A physician applying for licensure must have practiced in the field of Family Medicine for a minimum of 6 months in the last 3 years prior to date of the application. Any gap in practice, 3 years or greater, may result in ineligibility for licensure.

Mandatory Requirements	
Application	To be submitted through the physiciansapply.ca website
Language Proficiency	In English; both spoken and written
C.V.	Consisting of a chronological list of qualifications, professional appointments, and work experience. Indicating reason(s) for any gaps in practice history greater than 3 months and current to the date of the application.
Copy of Medical Degree	From a WDMS approved school
Copy of Certification(s)	Certification regarding the physician's Specialty from Canada or another country
Copy of Other Qualification(s)	Including but not limited to; USMLE's, ECFMG, NAC OSCE, diploma's, additional specialty training certification(s)
Copy of Medical Council of Canada results	At minimum <u>one</u> of the following: MCCEE, MCCQE Part I, MCCQE Part II (LMCC)
Copy of Authorization to Work in Canada	One of the following valid documents: Canadian passport, Canadian Birth Certificate, Canadian Citizenship, Landed Immigrant Certificate, Canadian Permanent Resident card, Canadian Work Permit
Certificate(s) of Professional Conduct	From everywhere the physician has <u>ever</u> worked and/or held licensure, including Educational and locum licenses. Please note that these must be sent directly to us from the originating Regulatory Authority and are only valid for <u>3 months</u> from date of issue and must be valid on the day licensure is issued.
The below Mandatory Requirements are to be completed after obtaining approval for licensure	
PEI Provincial Exam	Assess knowledge and understanding of jurisprudence, ethical standards, and standards of practice governing the practice of medicine in PEI
Payment of Fees	All College required fees paid
Liability Insurance	Copy of valid proof of Professional Liability Insurance
Requirements as Deemed Applicable by The College	
Copy of Complaint Document(s)	If ever the subject of a complaint with any Regulatory Authority; provide copies of the Letter(s) of Complaint, Letter(s) of Response, and Letter(s) of Conclusion.
Copy of Legal Action Document(s)	If ever the subject of a legal action, related to the practice of medicine; provide copies of the Statement(s) of Claim, Statement(s) of Defense, and Conclusion document(s).

Additional documentation and/or information may be required as deemed by The College of Physicians & Surgeons of Prince Edward Island.
